1. Collecting personal information

You can decide what personal information you provide to us. We will only collect personal information that you choose to provide. Where possible, we will enable you to select how we will use this information (for example, by choosing to opt-in or opt-out of receiving special promotional offers).

You may choose to provide us with personal information if, for example, you: contact us with an enquiry; register on the site, fill out a survey or other form with your personal information included; request us to provide you with information; enter a competition; post information to public areas of the site or participate in a promotion.

3. Use of cookies

In common with many websites, we use "cookies" to help us gather the following information from visitors to foodmice.com, for example:

- the IP address from which you access the site
- the type of browser and operating system used to access the site
